CLASSIFICATION PURPOSE:

The primary purpose of the Shelter Veterinarian classification is to direct veterinary services for County shelter.

JOB DUTIES:

Administer, develop, oversee, and implement the Franklin County Animal Shelter's preventative animal care program (e.g., vaccination, nutrition, de-worming, stress reduction, medical diagnoses, treatments, examinations, spay/neuter and trauma repair surgeries, etc.). (e.g., vaccination, nutrition, de-worming, stress reduction, spay/neuter and trauma repair surgeries, etc.). Perform examinations/evaluations, medical diagnoses, and treatment of animal illnesses and injuries. Spend up to 50% of job time with spay/neuter and trauma repair surgeries. Assist and coordinate with the Animal Care Manager to provide supervision and direction to the medical staff, to include veterinary technicians and veterinary assistants.

Oversee and monitor medical evaluations to ensure all laws pertaining to the practice of veterinary medicine are followed at the Shelter, including the Ohio Revised Code 4741.0 and 955.16 and proper DEA licensing. Oversee contracts with veterinary surgeons and relief veterinarians and maintain close contact with the local veterinary community, including the Ohio State University of Veterinary Medicine and Shelter Medicine colleagues nationally. Recommend policies and procedures pertaining to dog adoption, spaying and neutering, and other related Shelter community programs. May respond to inquiries related to diagnoses and treatment of animal illness and injuries.

Order medical supplies and equipment. Maintain Shelter's medical files, drug logs, documentation, and records. Provide written reports as requested. Oversee the Shelter's safety efforts as they relate to veterinary drugs, cleaning and disinfecting agents, chemical restraining and handling of animals. Attend various meetings, conferences, trainings, and workshops. Maintain regular and predictable attendance.

These duties are illustrative only and you may perform some or all of these duties or other job-related duties as assigned.

MAJOR WORKER CHARACTERISTICS:

Knowledge of public relations; agency policy & procedures; government structure & process; natural sciences; Ability to define problems, collect data, established facts & draw valid conclusions; prepare meaningful, concise & accurate reports; demonstrate dexterity to use hands skillfully.
